#### **Talented Boy Whose Dream Came True.**

Hayden Cox (age 7) of Bells Drove, has won a prestigious scholarship to become a chorister at Canterbury Cathedral.

Hayden has dreamed of being a cathedral chorister ever since he first saw the choristers at Ely. He was only 5 years old at the time! Even though his family are not musical, Hayden has worked hard at fulfilling his dream. Having already passed through a first audition, Hayden's dream finally came true on November 8th when, at the final voice trial, he beat 25 boys to win one of just



four available places for new choristers.

#### Fenland Road Safety Campaign (Charlotte's Way)

It's been a very busy time for the Campaign, since the printing and distribution of the Campaign's second major document, 'Aims and Objectives' in September and October, to all Parish, Town, and District Councillors.

Welney Parish Council became the first to confirm in writing its support for the Campaign's aims. The document was also sent to key employees of Cambs County Council in anticipation of a planned publicity launch in the Cambs Times on 24th

October, which featured a front page article and photo of Malcolm Moss MP with the Campaign organiser.

The preparatory meeting with Malcolm Moss MP helped focus attention on the need to secure County Council agreement that installing safety barriers on the principle Fen river roads is both feasible and would be helpful, and that it would be worthwhile seeking substantial special funding, in the first instance, from government, in order to help with the cost of such work.

An additional 'Manifesto' document was produced along with a new poster entitled 'Barriers Would Help' with a suitably bleak picture of the Forty Foot road, and along with all other major Campaign documents, was included in several packages which were then delivered on 30th October, in person, by the Campaign Organiser and Malcolm Moss MP to the House of Commons for the Prime Minister, Chancellor and Transport Minister, David Cameron, and the Shadow Chancellor and Transport Minister.

The visit attracted interest from local radio stations and BBC Look East and ITV Anglia News.

Care was taken to focus interview responses on the positive intention to help the Cambs County and Peterborough City Council with the financial difficulties they would incur if unaided with the cost of the work.

Strong criticism of the council's lack of attention to safety issues, especially on the Sixteen Foot road, had already been made in an earlier document 'Fenland Roads, a Local Tragedy, National Disgrace', which was posted in May, to the Cambs County Council Leader - Jill Tuck, and the Chief Exec Mark Lloyd.

It was hoped this might suffice, to alert senior Council staff that they would be wasting their time if they continued to act obstructively regarding the merits of barrier installation.

Sadly, Amanda Mays, the Cambs CC 's Team Leader for Road Safety Engineering, saw fit to indicate on TV that she had no intention of acknowledging the feasibility and potential merits of barrier use on these roads, and gave a  $_{7}$ number of highly dubious justifications for this.



A lengthy, detailed and highly critical letter was written to Ms.Mays, and copied to all other County Councillors, the CCC Chief Exec, and various others, and on the day of delivery a video was made of the Campaign Organiser summarising the issues noted in the letter and more. DVD copies of the film plus a 'November News' brochure were again prepared for widespread distribution, including to all County Councillors, and should have arrived at Shire hall by Friday 14th Nov.

Meanwhile, in response to the growing pressure from the FRSC and its supporters, the Council has at last realised the need to at least look like they care by authorising the renewal of reflective posts along the roadside. The result is a modest improvement in the visibility of the edge of the road, long overdue and metaphorically speaking 'clutching at straws' compared to what they actually need to do to make these roads reliably safer.

In a BBC Radio Cambs interview on 6th Nov. the Campaign Organiser stated clearly that there was a problem with the Council's "systematic misrepresentation of the case", for barriers. The Council's respondent at the time avoided making any comment on this issue, but soon after, what should have been a simple Police information video on driving safely on the Forty Foot, made on 23rd Oct. (viewable on the Cambs Times website), turned out to be a vehicle for the Council's ill-informed further attempt to grossly misrepresent the facts about the feasibility and merits of barrier installation.

Two further Substantive Campaign documents have already been produced and hand delivered to Shire Hall, completely dismantling the premise of the Council's DVD. Electronic copies can be requested from: chappell@frsc.co.uk.

Regrettably it seems the Campaign must fight the Council's so called 'Road Safety Team' from top to bottom to have a chance of removing the obstacle they seem determined to sustain, for reasons that seem to have been lost in the mists of time, to the installation of further safety barriers

#### "A Dog Is For Life Not Just For Christmas!"

I'm sure we've all seen the car stickers "A dog is for life not just for Christmas", but it still surprises me how many "dog lovers" still don't realise what a responsibility they are taking on when they first own a dog. Over 50,000 dogs are re-homed every year because their owners cannot look after them any more. This may be because of a change in circumstances making it impossible for the owners to care for the dog any more. Sometimes it's because the owners can no longer deal with the dog – it's too boisterous, too big or has significant behavioural/health problems etc. It is sad to say but every year over 5,000 dogs are put down because they are "difficult" dogs.

So if you are thinking of getting a dog this Christmas or indeed at any time through the year then please take time to think about and act on the following.

Firstly, consider taking on a rescue dog – I know it's not a cute puppy and it may have some behavioural problems, but in the right home it can blossom and give much joy to the family. I had a rescue dog for 18 years and it was the most loving and good natured dog you could want.

If you want a puppy then research the breed that is right for you. Don't just choose a breed because you like the look of it. Contact the Breed Associations and talk to as many owners of the breed as possible. Think about your own lifestyle. Are you going to be able to give it the exercise it needs? Is it going to be left at home alone for significant periods? Is your home suitable for the size of dog you want? All breeds are different, not just in their looks but in their temperament and their requirements. For example, the Border collie is an extremely popular dog – we've all seen it on Crufts and at dog shows excelling at obedience and agility. They are very clever and quick to learn dogs. However, because they are so clever they need an even cleverer owner to keep them happy and well balanced. If you don't give them enough to do, then they go what I call "self employed" - doing things that are often not appropriate to relieve the boredom – becoming destructive or becoming territorial for example. Of all the dog breeds there are more border collies that go for re-homing than any other breed! If you have no experience with dogs then a Border collie is NOT for you.

So you've chosen your breed carefully or have identified a rescue dog.

If it's a registered breed dog then check out the health of the parents. Some of you will have seen the recent television program about the poor state of health of some of our dog breeds. Find out the health problems of the breed and check whether the parents have been screened for the condition. I have had a number of Labradors and I have never bought a puppy without firstly having seen the parents (to be sure that they are not "psycho!") and that both parents have been hip, elbow and eye tested. Sure, it's no guarantee that the puppy is not going to have any problems, but it's less likely and anything that keeps vets bills down can only be good. As soon as you get your puppy you should take it to the vet to get it health checked and vaccinated against all the nasty and fatal diseases that dogs can get.

Health checking with rescue dogs is more difficult as the parentage will probably be unknown, but reputable rescue centres should have the dog checked over by a qualified vet so that they aren't knowingly handing over a very unhealthy dog. As soon as you get it, take it to your own vet for checking and inoculations.

Get Pet insurance. These days the number of illnesses and conditions that are treatable by a vet (with appropriate costs) is staggering!! Insurance can save an awful lot of money. There are many insurers out there, but do read the small print! Many of the cheaper ones



do not for example cover life long illness or they have a maximum that they will pay out for any one condition. Should your dog suffer from say epilepsy or diabetes, the insurance will only cover them for the first 12 months

or until the maximum cost is reached, and then it's up to you!!

Before you bring your dog home, check that you have everything in place – a bed, food, bowls, a collar and name tag, a lead, a few toys, things for it to chew, paper towels for those accidents which are certain to happen etc. Also you need to decide on the house rules and make sure that all members of the family are aware of what they are. For example, are you going to allow the dog on the furniture? It's no good if one member of the family decides it's fine for the dog or puppy to take the comfiest chair if the others are making it keep off all the furniture. The dog needs clear and con-

sistent messages otherwise; it gets confused.



Dogs need exercise – chucking a dog out in the garden is not enough. I once did some video recordings of two dogs that were left in the gar-

den all day. Guess what they did? Played for a bit, sniffed for a bit and then curled up in a sunny corner and went to sleep. When the owner came home, they were well rested and raring to go. The energy they had was then used to play fight with each other in the house, fight over toys, destroy the furniture when the owners' back was turned and generally be totally out of control. Walking a dog brings a closer bond between dog and owner, it shows the dog that you are the leader, it gets rid of the pent up energy and you get fitter!! If you cannot give your dog regular exercise, then DON'T get a dog. Depending on the type of dog will determine the amount of exercise – small dogs generally need less, but this is not true for all breeds. Some big dogs don't need much, greyhounds for example are sprinting animals

are not built for stamina. Puppies don't need a lot of exercise in the first few months, but the amount should slowly increase as they get older and their bones develop.

Dogs need food and water. This is a significant cost you will have to take into consideration. A balanced diet for a human is not a balanced diet for a dog!! Therefore you must feed your dog with dog food to ensure it gets all the nutrition it needs to stay fit and well. Some dog owners feed their dogs natural foods like raw meat etc. This is fine providing you have done your research on the full range of nutrients that a dog requires e.g. Vitamins and minerals and these are included in the dog's diet. Personally I have enough trouble making sure that my own diet is well balanced and nutritious without worrying about the dogs and so I'm more than happy to purchase a reputable dog food for my dogs and they appear to do well on it. Also, some human food is toxic to dogs e.g. grapes, sultanas, raisins and chocolate. Some dogs will tolerate small quantities, but some won't, so it's better never to let them develop a taste for them. I know a dog that helped himself to a dozen mince pies and then ended up spending Christmas at the vets. A very expensive Christmas!!

Dogs need leadership. Dogs are a pack animal and if the members of the family are not recognised by the dog as leader, then the dog may try and take over that role. Here consistent rules will help. Things that can give your dog ideas above its station are being allowed to push past you as you go out the door; lying in the doorway so that you have to step over or go round the dog; demanding attention and getting it and pulling on the lead so that the dog is always ahead of you. These are just a few examples and space does not allow me to go into any detail on what you might do in such circumstances. Dog behaviour is a huge subject and the solution must be appropriate for that particular dog. It isn't a case of "one size fits all" as all dogs are different, just like us humans.

Well, having read all this and you would still like a dog for Christmas – ENJOY! I hope that you have many happy years with your four-legged companion – I certainly wouldn't be without mine!

Development of the village's mains sewerage system will take its own course and is, fortunately, out of our hands, but plans for a new Community Centre will provide an opportunity for everyone to get directly involved. Indeed, it'll be essential that many of you do if this highly ambitious project is to be successful.

Although we are likely to receive substantial grant aid towards the new building, including a probable contribution from our very own Wm Marshall Charity, there will still be the need to undertake some local fundraising in order to complete the project.

The continuing existence of a "friends" group that support our school demonstrates well that there are already a number of highly motivated people living in and around Welney. The success of the 2007 Children of Welney Fayre is a good example of this. Now we need a few more to step forward and get involved with the organisation of events large or small that will have the capacity to raise funds that can be ploughed into worthwhile village causes, such as the Community Centre and its associated children's play area.

The Parish Council would be very happy to facilitate the setting up of some kind of group committed to raising funds for the benefit of the village. The Council does not want to take the lead, but is keen to support anything creative that will both raise funds and the profile of the village, portraying it as a vibrant community that we all live in. This is a real opportunity for anyone to come up with something really original that will draw people to Welney from far and wide to part with their money. The days of simple village fetes and even raft races have largely been consigned to history, but if Witcham can come up with the World Pea-Shooting Championship and Ashton the World Conker Championship what bizarre attraction can Welney come up with?

If, over the next few weeks, you come up with some potentially eyecatching scheme, or would be prepared to simply lend a hand in some way, please discuss it with any PC member or our clerk, Pat Copeman, on 610226.

Providing that there is a large enough response we may arrange a public meeting in order to move any suitable ideas forward.

#### The future of Welney Water Tower.....

On the 7th of October I had the opportunity to present to the Parish Council my plans for the disused Welney Water Tower. The Editor of the Welney Magazine having learnt about my ideas contacted me with this opportunity to use the Magazine as a means to letting the village know about my design thoughts. Although at very early stages in the design I hope that some of my illustrations give an idea of the sculptural conversion interests I have for the structure.

In my presentation to the Council I put the below listed points superimposed onto a photograph of the tower next to the Church. This photograph is aptly titled "surreal" on the Norfolk Churches Web site. I want to achieve a building that is landmark, contemporary and in fact in harmony with the Church so as to almost be a part of the building like a Church Tower. The design will offer viewing outwards to the Welney vistas and with no windows allowing "lookout" views into any exisisting residence.


For some the tower is an ugly blight on the horizon, others may be so used to it that they

do not actually even notice its dominance any more. As an outsider I can tell you that on visiting Welney the tower is unavoidably dominant and ugly, and very surreal. Obviously my ideas are not going to be to all tastes. I just hope that they are for all residents at the very least something that is better than the existing structure. With regards to the ongoing design process I am open to any residents views. Please let me know what you like and don't like; by all means send a drawing of your ideas, or sketch changes onto my design (welneywatertower@yahoo.co.uk). Whilst I may not be able to satisfy all I do encourage any resident that can add critical intelligence to the design to be actively involved in the evolution of the structure.

Following "informal planning advice" that I have recently received from Kings Lynn & West Norfolk planners it has transpired that English Heritage and Conservation have to support the concept that my conversion designs offer an improvement to the setting of the Grade 2\* listed St Mary Church. This is indeed a large permission hurdle in its own


right. There may be opposition to any acceptable conversion design, no matter how meritorious and visually improving, on the grounds of a lack of amenity space. The plot on which the tower exists is hemmed in by properties belonging to two considerable landowners. Through no fault of their own these landowners may ultimately hold a ransom on the towers' progression from the drawing board. To this end I very much hope the neighbours in particular will be open to the idea of working with me and influencing the design so that they have at the centre of the village, and at the end of their gardens a building which they designed to work best for them. I am trusting to the idea that participation in the design, rather than objection through planning will help create a building that is very much designed by the neighbours. I recommend "where there is a will there is a way" works better as a partnership rather than forcing the will of my individual design on unwilling neighbours and/or community. Maxims aside, ultimately for the conversion to become a reality and get beyond the drawing board it is clear that the neighbours have to see the conversion as something of value to the village and therefore worthy of their support.



#### **Bullet points of Water Tower Presentation**

- 1. **DESIGN AMBITION:** My ambition for the tower is to place next to the church a landmark building – one that would add aesthetic value to the village. I would not be interested in a basic planking of the structure. I am looking at a more sculptural direction. I am trying to reach for a dwelling that villagers are proud to behold and one that is a regional landmark building.
- 2. DESIGN TO BE A COMMUNITY PROJECT: Being such a prominent structure the design ambition is of course architecturally very challenging. With this direction in mind I would like you to consider being a part of the process of transforming the tower and therein the village. I am looking for a contribution to the design and support from the community to include neighbours and the Parish Council. The water tower is very much "the ugly duckling". . . .
- 3. PARISH COUNCIL: I am mindful of the will of the Parish Council that the water tower should be demolished. (Parish Council minutes of the 14th June 2006). I think demolition is a missed opportunity. Whilst the structure dominates in the way it does as an ugly blight on the village demolition is an understandable desire - however if the design ambition can be achieved Welney would be the better for having a unique landmark building in the village. Since it is in private ownership an opportunity now to create a landmark is better than spending many years in the future with the existing dominant and ugly building in the village.
- 4. **NEIGHBOURS**: The Marshalls Charity and the Grange have the most to gain from having a landmark building on their borders. Far from rejecting this opportunity to be actively involved in the development they should add their support. It is a project of value to the village especially as the transformation will improve the vista of their dwellings coupled to the Parish Church.
- 5. Neil Trodden: A nice person to have as a neighbour!

#### **Denver Sluice - Little Eye Sluices Refurbishment Work Completed**

ENVIRONMENT AGENCY

The repair work to the three sets of timber 'V' doors has been completed and they were returned to operation on 24<sup>th</sup> October 2008.

The downstream, tidal faces of all the doors have been over-clad with 25mm thick marine plywood for the top 4.8 metres of each door Detailed inspections had shown that following these repairs the condition of the doors should give a further five to ten years of working life.

#### **Future Operation of the Sluices**

In times of high flows in the tidal river it is not possible to discharge flows from the Ely Ouse through the Little Eyes. In a wet winter or a drought summer water levels can prevent any discharges from being made through the sluice for many months. This can cause silt to rapidly build up against the downstream face of the doors. In the past, if the silt deposits became too deep, re-opening the sluices was an expensive and time consuming operation.

So, at the same time as the repair work has being carried out, an experimental air injection system has been installed.

This system will use compressed air to disturb any silt that builds up in front of the timber 'V' doors. With this system in place the Environment Agency will be able to quickly return the doors to proper use as soon as the river water levels allow.

Discharges through the Denver Sluice form a fundamental part of the implementation of the Environment Agency's long term Tidal River Strategy for the management of silt deposition in the tidal river.

As part of this strategy the Environment Agency will endeavour to discharge as much flow as possible from the Ely Ouse River through the Denver Sluice, rather than using the adjacent A G Wright (Head) sluice and the flood relief channel. Calculations have indicated that the fresh water from the Ely Ouse river is beneficial in reducing the build up of silt in the Great Ouse tidal river between Denver and Stow Bridge. It is anticipated that this will benefit both the navigation between Denver and Salters Lode, and the ability to drain the Ouse Washes by gravity through the Welmore Sluice.

The discharge through the Denver Sluice is dependent on the tidal cycle, with maximum discharge occurring at low tide and no discharge at all at high tide. This will lead to the water levels in the non-tidal Ely Ouse River fluctuating with the tidal cycle. The amount the water levels change within a cycle will vary depending on the river flow conditions and the height and duration of the of the high tide levels.

The Ely Ouse river water levels are carefully monitored and there will be No increase in the risk of flooding as a result of this strategy. The flood flows in the Ely Ouse river will continue to be discharged down

the flood relief channel via the A G Wright (Head) sluice.

During a flood event discharges through the old Denver Sluice are usually not possible, as the Great Ouse river would also be in flood and so water levels at low tide never fall below the managed water level of the Ely Ouse river.



#### FARMING DIARY

Thankfully all is safely gathered in. Well, almost. All the harvesting of crops that we do ourselves is complete, with the only outstanding harvest being 55 acres of sugar beet, which we are awaiting the 'Ropa Tiger' of Russell Company to come and harvest for us. We are expecting about 26 acres to be lifted any day now with the remainder to be completed in early December.

Once the beet is out of the ground we can move in with the plough and grain-drill so we can drill the last of the winter wheat seed of the season. Yesterday (15th Nov) we completed the wheat drilling of all cleared fields to date and are now just waiting for that sugar beet to be cleared. Drilling of wheat is split between three varieties



this season; Solstice for high quality bread making flour; Einstein for second grade milling flour, where it will be used in part of the grist; and Oakley which is a feed wheat only to be used as the ingredient in animal feeds etc where flour making quality is not so important. The varieties that produce a good milling variety will have higher protein content and the important aim of growing these varieties is to achieve the minimum level required. This level is set by the millers and can vary when there is a shortage of high protein wheat, but in general would be above 13%. This is helped by the addition of extra nitrogen fertiliser during the growing season.

Keeping the crop both disease and insect free so the grains are bold at harvest time and not shrivelled is also important for quality. Shrivelled grain in turn lowers the specific weight of the grain which is important for meeting milling requirements. The bushel weight, or as it is now known the specific weight, is calculated by weighing a litre of grain, and for milling wheat this generally needs to be above 76kg/hl (in other words 1 litre of grain will need to weigh 760g). If a grain is shriveled it will not contain as much flour as a bold grain, so the miller will only buy above this spec so that he gets more flour per ton of wheat purchased. Also a higher bushel weight means more weight of wheat can go in to the

lorry or boat - quite an important criteria when calculating how much wheat is to be put in the hold of a ship. Another important specification to achieve when growing milling wheat is the Hagberg Falling Number or Hagberg as it is simply known. This should be over 250 and is a measure of the gelling properties of the flour, which is obviously important if you are going to make bread or biscuits etc. So, next time you pick up a loaf of bread, just remember it is not just any old field of wheat that goes to produce high quality flour. Further information for those interested can be found at www.hgca.com or www.nabim.org.uk

Our potatoes have all been harvested and either delivered to McCain or stored ready for a later market, and quality this year seems to be better than last season with wastage from grade-outs not so high. Some of the crop in store is destined for McCain, one variety (Vales Everest) is going to Birds-Eye, while the remainder

will hopefully be going into 25kg sacks to supply the fish and chip shop trade.

Sean is now busy with the tractor and plough turning the land over at a depth of around 12 inches per furrow. This prepares the land for the winter and the next crop that will be planted in the spring. By ploughing the land residues from the last crop are buried so they can be broken down by bacteria etc and add nutrients to the soil. The ploughing also helps to condition and aerate the soil ready for the new crop. The plough penetrates to a depth of about 12 inches and each furrow is taking a slice of 16 inches. Each 'pass' is moving 80 inches width of soil as the plough passes through the field.

I, like many other tractor drivers in the area, have a CB (Citizen's Band) radio in the cab which enables me to talk with other drivers who also have these radios, so long as they are within a range of about 10 miles. This is extremely useful when organizing farm activities between Sean and myself and saves a lot of hand signals to each other which often get incorrectly interpreted, even when we are working in the same field. CB radios are also very useful when observing criminal or potential criminal activity, and while drilling in Outwell last week I heard one driver warning of two or three vehicles containing hare coursers poaching over farm land. These people ran and drove off when the farmer went to challenge them, but due to the location of various CB operators they were tracked out of Norfolk and over the border

into Cambridgeshire where they then set off with the dogs on some more remote farmland to chase hares. It was not long before excited chatter on the CB reported the Cambridgeshire police helicopter and many police cars in the area. One of the CB operators reported the helicopter landing in a field and two police officers leapt out and gave chase and we understand several arrests were made before any serious damage to the hare population occurred. This illustrates how rural communities can work together to prevent crime, and it is important for us all to look out for each other and communicate with our neighbours and if you do see anything suspicious, report it.

It is at times like this that you can reflect on how things used to be done and it was while researching material for the W.A.S.H (Welney Archive and Social History) archive that I realised it was not so many years ago when men sat on tractors without cabs and only a hat and coat to protect them from the elements, yet the work was still done on time.

The Welney Archive has quite an array of photos and articles depicting life in and around Welney up to the present day. The archive to date has been stored on hard copies and also scanned into computer format to preserve the quality of all the images and documents. The information has been collated into groups for easy reference, such as village scenes, the Wash, farming, village folk, school, church, weddings, sport, galas etc. Once again we will be opening the archive for free public viewing, and this will be in the Parish Hall at Welney on Saturday the 7th of February between 10am and 1pm. There will also be light refreshments available.

Photos will be displayed along with a rolling display of images from the computer displayed on screen. We would also welcome any other photos, articles or newspaper cuttings that relate to life in and around Welney that could be saved for future reference. If you know or any persons that may have moved away from the village and have material that they would be happy for the archive to use then please get in touch with either myself, the Welney News or the parish clerk. The Parish Council has stored this information safely for future generations and already the pupils of William Marshall School have been provided with a CD copy for use with their historical research of Welney. It is also planned to place a CD copy of this material once it is all labelled in the Norfolk Archive.

Christmas will soon be on us now and may I use this column to wish all of you a very happy and healthy Christmas and a prosperous New Year.

#### **Upwell Health Centre**

Computers are meant to make life easier for us all; most of the time I think they do. There are days though when that is definitely not the case; for example when the health centre computer system goes down and we have to work without any idea of who is coming to see which of us, what their medical history is, what their test results are nor what drugs they take!

However, one way our computer system can make life easier for you is if you take advantage of its ability to allow you to book appointments and order repeat prescriptions over the internet. In 2006 57% of households in England could access the internet. That probably means about half of our patients have internet access and could avail themselves of this service.

For appointments it means you will be able to log on at a convenient time for you and book an appointment with the doctor of your choice. This saves you having to phone us which frees up our staff and saves you time. At the moment not all the appointments are bookable on line so please feel free to ring for an appointment if there is nothing suitable available on line. Currently with repeat prescriptions you have to get your repeat slip to us which can mean a time consuming journey to the surgery. Ordering your repeat online means you only have to make one journey to actually pick up the drugs themselves. It also means you can order them at a time convenient to you, for example when we are closed. Of course you can only order drugs that have been authorised for repeat by your GP.

So how do you access these services? Doctors are very concerned regarding patient confidentiality and we need to be sure that only you can access your own data on our system. Therefore anyone using the internet to access our computer needs to have been issued with individual log in data. If you want to use these services then go to reception and register for your own personal log in details.

The flu campaign is in full swing. This year we held three sessions on Saturday mornings at the surgery instead of the big Health Fair at Upwell Hall. These were very successful with large numbers attending and having very short waiting times. However, there are still a lot of you out there who have not had your flu injection. Remember these are recommended to anyone with heart disease, lung disease, diabetes or kidney disease as well as everyone over 65. Anyone who has had proper flu will testify that it is much more than a bad cold and it really can lay people low especially when they have any other chronic illness. If you think you should have a flu injection ring us up and book an appointment straight away. Don't forget to ask about a pneumonia vaccination if you have not had one, these are recommended for the same sort of people as the flu jab.

Finally I would like to take this opportunity to wish all of you a merry Christmas from us all at the surgery. We will be open as normal up to and including Christmas Eve. We will be closed Chrsitmas Day and Boxing Day and will be open as usual on Monday 29th December. We will also be closed on New Years Day.

Mr. Neil Trodden addressed the meeting with his proposals for the **Welney Water tower**. He advised Council that he had agreed terms with the owners to acquire the Water tower but would like to show members his design thoughts for a residential redevelopment.

Post Office Services - The Mobile Post Office Van is now visiting the village every day between 1.15 and 2.30 p.m. Trade is slowly increasing and they are looking at plans to possibly resite the Post Office service in the future.

Code of Conduct and Cllr.Kerr - A letter of support for Cllr.Kerr had been sent to the appropriate authorities.

Local Government Reorganisation - The letter confirming Council's request that the present local government tiers should remain the same as at present had been sent off to the Boundary Committee.

First time Sewerage for Welney - A planning application had been received from NCC relating to the aerated facultative Lagoon Treatment Facility required by Anglian Water Services at Green Lane off Padgets Road, Tipps End. Before the matter was considered Cllr.Goodger declared an interest and left the room. It was unanimously agreed that the application be recommended for approval. Enquiries had been made of the Borough Council regarding any grants which might be available for this work to individual householders and whilst some financial assistance may be available, only certain householders would be eligible. The Clerk reported that the Parish Hall had been booked for an Open Day on Thursday 4th Dec from 2 - 7 p.m. and letters to all those properties in the catchment area, would be sent out shortly.

Parish Hall - A cause for concern was the state of the lean-to store at the back of the Hall and it was agreed that councillors would meet on Saturday 1st November in order to have a clean up and remove all the old rubbish.

Proposed New Community Centre - Nothing further had been heard from Norfolk ProHelp nor the EA despite repeated requests for information. It was agreed to provide details of architects and companies that might be able to draw up plans for the Hall in order that matters could be moved along. This would be dealt with at the next meeting. Freedom of Information Act Model Publication Scheme - Details had been received and it was proposed, seconded and agreed that the Parish Council should formally adopt this Scheme with immediate effect.

**Planning permission** had been received for Extension and Alterations to dwelling at School House, Suspension Bridge, Welney.

Planning Application for consideration - Mr.Purliant, Change of use of pasture land to an all weather turnout area at Copes Hill Barn, Wisbech Road, Welney. It was agreed to recommend this for approval, but to mention that concern was raised with regard to possible use of floodlighting on the area, and the possible hours of use. Highway matters -Before the meeting Councillors met in the car park outside the Parish Hall to inspect the problems caused by lorries turning, when the Wash Road floods. It was agreed to write to Highways expressing concern and asking them to consider widening the entrance so it is not churned up. It was accepted that there must be somewhere for these vehicles to turn, but it was felt that a wider access would make this much safer, and would also go someway to safeguarding the properties in the Immediate vicinity.

The following items were reported to Highways for attention: Rutland Corner at Tipps End is in a dangerous condition following an incident where a lorry went off the road; Some of the signs in the area have been painted with yellow paint and some have been turned round pointing in the wrong direction; a large area of water accumulates on the roadway outside Bridge Farmhouse at Suspension Bridge, and also on the lay-by at the entrance to the School where the drains appear to be blocked; several of the roadside marker bollards on Wisbech Road have been damaged and broken.

#### Parish Council Brief Report



The November meeting was held in the Parish Hall on Tuesday 4th at 7.30pm

**Local Government Reorganisation** - Two representatives had hoped to attend the meeting at King's Lynn on 15th October but this had not been possible. However, information had been received relating to that meeting and it was agreed that two councillors would book places at the next meeting on 7th January, 2009.

**SAM Monitoring** - It was confirmed to the meeting that on 25th October the SAM "Smiley Face" vehicle was in and around the village. The Clerk had spoken to the gentleman operating the equipment and he confirmed that he had good records of the speed of vehicles both entering and leaving the village, in two separate locations. These would be collated and sent to Council in due course. At the same time the Police were carrying out speed checks situated at the entrance to the School.

Code of Conduct and Cllr.Kerr - The Standards Committee Panel Hearing Agenda had been received from the Borough Council and this would take place on Friday 7th November at 11 a.m. (See pages 24 & 25)

**First time Sewerage for Welney** - Letters relating to the Open Day on 4th December had been received from Anglian Water Services. A letter had been received by the Parish Hall but it was unanimously agreed that the Hall would not be connected to the mains sewer.

Parish Hall - Thanks were expressed to those who attended the Hall on 1st November and assisted with the clean up in the Store at the rear of the Hall. A great deal of rubbish and broken items had been removed and the space is much cleaner and more easily accessed. Two heaters in the hall have again stopped working and an electrician would be asked to check these out.

**Proposed New Community Centre** - Confirmation had been received from Norfolk ProHelp that they had found a company willing to carry out the Flood Risk Survey. The Chairman confirmed that he was hoping to attend the Norfolk ProHelp Exhibition in Norwich on 11th November and he would try and find out further information. A letter had been received from the EA relating to Council's purchase of the Hall site.

**Quality Council Status** - The Clerk confirmed that she had received information relating to this from the Norfolk Association of Local Councils and that we now met the basic criteria if we wished to proceed towards Quality Status. In view of the work involved it was agreed to leave this matter in abeyance and visit it again in the future.

Marshalls Charity - A letter was received confirming that Mr T Bray had resigned as a Nominative Trustee. After consideration it was proposed that Mrs Rachel Brown should be appointed to fill the vacancy.

The following **planning applications** were received & recommended for approval.

Mr.C.Haycock, Alterations and Extensions to dwelling house at School House, Suspension Bridge, Welney. Anglian Water Services, Proposed Temporary Vehicular Access and 6 Parking Spaces for residents (for a period of 12 months from 1.1.09 during the construction of the Vacuum Pumping Station) on land to the north of 33 Chestnut Avenue, Welney.

Highway matters - Confirmation had been received from Highways that the reflectors will be replaced where missing and broken, and that drainage investigations will be carried out near Bridge Farmhouse and the lay-by at the School Entrance. The painted street names are the responsibility of the Borough Council who had promised to deal with the matter.

Following the last meeting Highways representative had met the Chairman on the car park near the Hall and subsequently the entrance to the roadway had been widened. Concern had also been expressed to Elgoods regarding lorries parking overnight on the car park but nothing had been heard.

**WASH Committee** - The committee met on the 17th Oct and arrangements made for an Open Day in the Parish Hall on Sat 7th Feb, 2009. Full details would be available in due course.

The next meeting would be held on Tues 2nd December.



#### The swans are back!

We are heading into winter and the reserve is looking fantastic at the moment with plenty of swans arriving each week. The first arrivals were a group of Whooper swans who landed on the reserve on 2<sup>nd</sup> October. We have just recently welcomed the first Bewick's swans back on the reserve, spotted on 3<sup>rd</sup> November. Numbers of wildfowl including Wigeon and Teal are increasing as the winter progresses.

The Bewick's swans caused quite a stir this year turning up about 10 days later than normal. With 2,500 miles to fly they won't migrate unless the wind is in the right direction and cold weather forces them to move south. With the winds blowing from the south-west for much of October and mild conditions in their breeding grounds of Arctic Russia it was no wonder they decided to take a bit longer this year. Numbers are on the increase and we expect up to 5,000 Bewick's swans to spend the winter at Welney again this year.

The Festival of Swans took place on 15th & 16th November. This popular event takes place every year to welcome back the migratory swans to the Fens. 2008 was our best year yet with more talks, more demonstrations and more exhibiting artists than ever before to entertain visitors. Not forgetting huge numbers of the stars of the event – the swans! If you missed it, don't worry the Festival will be back next year and there are plenty more events going on over the next few months. Don't forget you can come and watch the swans being fed everyday until March 15th 2009!

Besides the swans there has been much excitement at Welney around our new Lady Fen land. The project to convert 100 acres of farmland beside the visitor centre to wetland has been going on for 18 months now and was recently finished. The autumn rains have started to wet the land and many species of bird including Ruff, Curlew, Skylark and Whooper swan have already started to call this new area home. An open day is planned for February to let people find out more about the wildlife using Lady Fen so keep watching this space.

And finally... we must mention that WWT Welney recently won the 'Small visitor attraction of the year award' at the East of England Tourism awards. This is the second year the centre has won this award as well being highly commended in the 'Sustainable Tourism' category.

#### Section 1: Preliminary documents

The referral from Ethical Standards Officer:
On 8 February 2008 the ESO referred an allegation about Cllr Steven Kerr to the Monitoring Officer for investigation. The allegation was investigated by Teresa Campion, Deputy Monitoring Officer who prepared a report of her findings. The Investigator's report concerns a possible breach of the Code of Conduct:

Allegation 1: Code of Conduct 2001, paragraph 12 Code of Conduct 2007, paragraph 13

Allegation 2: Code of Conduct 2001, paragraph 8 Code of Conduct 2007, paragraph 9

Allegation 3: Code of Conduct 2001, paragraph 5(a) Code of Conduct 2007, paragraph 6 (a)

Allegation 4: Code of Conduct 2001, paragraph 10 Code of Conduct 2007, paragraph 12

of the Regulations. The Investigator referred her report to the Standards Committee for a hearing in accordance with the Regulations.

The allegation was that Cllr S Kerr failed to comply with paragraphs 12,8,5(a), and 10 of the Welney Parish Council's Code of Conduct 2001 and paragraphs 13,9,6 (a) and 12 of the Welney Parish Council's Code of Conduct 2007 in that he:

failed to register details of his financial or other interests (allegation1)

failed to declare a personal interest in the matter of Meadow Lane when it was considered by Welney Parish Council (allegation 2)

Used his position or attempted to use his position as a member improperly to confer on or secure for himself or any other person, an advantage or disadvantage (allegation 3)

Had a prejudicial interest and failed to act appropriately (allegation 4).

The complaint was made by the complainant to the Standards Board for England and was referred for local investigation by the Borough Council of King's Lynn and West Norfolk by the Ethical Standards Officer, Jennifer Rogers in February 2008.

Section 2: Oral and written submissions (procedural)

2.1 The Standards Committee's decision on any procedural matters was as follows:

Cllr Kerr was present at he hearing. He was accompanied by Mrs S Kerr who represented the case on Cllr Kerr's behalf. There was no request made for the press or public to be excluded and the hearing was conducted in open session. Cllr C Walters, a member of the Standards Committee was present for training purposes only and took no part in the hearing.

Two Welney Parish Councillors were also present during the hearing as observers.

The Investigating Officer called the Complainant, Mr M Smith as a witness. Mr Smith was only present during the hearing during the time he was giving evidence to the Panel.

Following the announcement of the Panel's decision Cllr Kerr was advised that the result of the proceedings in respect of the allegation which was found proved would be published but that he had the right to ask for publication of the results of the allegations which were not proved to be withheld from publication. He was permitted until 5pm on the 10th November 2008 to consider this but it was made clear that if he had not contacted the Monitoring Officer by then the results in respect of all the allegations would be published.

#### **Section 3: Findings of fact**

- **3.1** The following facts in the Investigator's report were undisputed and the Standards Committee findings of fact are:
- a) That Cllr Kerr is a member of Welney Parish Council
- **b)** That Cllr Kerr resides at Croft House, Main Street, Welney and that he operates his carpentry business from this property.

#### 3.2 Summary of evidence:

As detailed in the Pre-Hearing Summary and the Investigating Officer's Report.

Cllr Kerr produced various photographs and plans to show the nature and location of Meadow Lane and the 'made-up' stretch of lane to the side of his property which leads to the local school. He also produced letters from previous owners of Meadow Farm and a previous occupant of accommodation in the local school which supported the view that Meadow Lane did not include the 'made-up' lane to the side of his property.

#### 3.3 Summary of submissions about disputed facts:

Allegation 1 – Cllr Kerr completed the declaration of interests form following his reappointment to the Council in May 2007 and handed it to the Clerk of the Parish Council. The Clerk failed to forward this to the Borough Council's Monitoring Officer.

Allegation2 – The Complainant contends that the 'made-up' lane which runs to the side of Cllr Kerr's land and leads to the local school is part of Meadow Lane. As Cllr Kerr uses this 'made-up' lane to gain access to parking spaces on his property which he uses for his business and personal interests he should have declared a personal interest when the Parish Council were considering matters relating to Meadow Lane at meetings held on the 9th November 2004, 11th January 2005, March 2005, 14th June 2006, 12th July 2006, 11th April 2007 and 9th May 2007. Cllr Kerr and members of the Parish Council believed that when they were considering issues relating to Meadow Lane they were dealing with an unmade up lane which did not form part of the made up road at the side of Cllr Kerr's land.

Allegations 3 & 4 – The Complainant contends that when the Parish Council considered whether or not to support a right of way application in relation to Meadow Lane (which he believes includes the 'made-up lane referred to above) that Cllr Kerr stood to gain a beneficial interest for his property and business by securing a right of way. As such he not only had a personal interest but also a prejudicial interest which should have been declared. Furthermore in actively supporting the right of way application at Council meetings he sought to secure a significant advantage for himself. Cllr Kerr and members of the Parish Council believed that when they were considering issues relating to Meadow Lane they were dealing with an unmade up lane which did not form part of the made up road at the side of Cllr Kerr's land.

# Section 4: Standard Committee's finding of fact and decisions on whether the Codes were breached

4.1 Allegations 2,3 and 4

From the evidence submitted the Panel were satisfied that when the Welney Parish Council considered the question of Meadow Lane on the:

14th June 2006,

12th July 2006,

11th April 2007 and 9th May 2007

It believed it was dealing with the unmade road which has been described to the Panel at the hearing. This did not include the made-up road to the side of Cllr Kerr's property and which leads to a local school. The Panel believes that Cllr Kerr was also of this understanding. The Panel therefore concludes that Cllr Kerr was under no obligation to declare a personal interest at these meetings as his business and property interests were not affected nor would he be affected to a greater extent than others.

The Panel therefore finds the allegations in respect of these dates are **not proven**. For the same reason the panel finds that the allegation that Cllr Kerr had used his position to confer on or secure for himself or any other person, an advantage or disadvantage – **not proven**.

So far as the allegations that Cllr Kerr failed to declare a personal interest at the meetings held on: 9th November 2004, 11th January 2005, March 2005

The Panel is of the opinion that the Council was not being asked to make any substantive decisions and therefore there was no obligation on Councillor Kerr to declare a personal interest.

It follows from these findings that as Councillor Kerr <u>had no</u> <u>personal interest</u>, <u>therefore no prejudicial interest</u> <u>could have arisen</u>.

#### 4.2 Allegation 1

So far as the failure to ensure that Cllr Kerr's declaration of interests was served on the Borough Council's Monitoring Officer in May 2007, the Panel is satisfied he failed to do so and is therefore in breach of the Code of Conduct.

Allegation 2: Code of Conduct 2001, paragraph 8 Code of Conduct 2007, paragraph 9

Allegation 3: Code of Conduct 2001, paragraph 5(a)

Code of Conduct 2007, paragraph 6 (a) Allegation 4: Code of Conduct 2001, paragraph 10

Code of Conduct 2007, paragraph 12

Cllr Kerr **did fail** to comply with paragraph 13 of the Code of Conduct 2007 (Allegation 1)

Cllr Kerr did not fail to comply with

Allegation 2: Code of Conduct 2001, paragraph 8
Code of Conduct 2007, paragraph 9

Allegation 3: Code of Conduct 2001, paragraph 5(a) Code of Conduct 2007, paragraph 6 (a)

Allegation 4: Code of Conduct 2001, paragraph 10 Code of Conduct 2007, paragraph 12

#### **Section 5: Sanction**

The Panel decided **not to impose a sanction <u>but</u>** explained to Councillor Kerr that it was an important duty upon all Councillors to ensure a copy of the Register of interests was forwarded to the Monitoring Officer at the Borough Council and to make sure this did not happen again. The Chairman advised that it was important to relay this to the Clerk and to colleagues of Welney Parish Council.

#### Section 6: Right to appeal

6.1 Cllr Kerr has the right to apply in writing to the President of the Adjudication Panel for England for permission to appeal the Panel of the Standards Committee's finding. The President of the Adjudication Panel must receive written notice requesting permission to appeal within 21 days of the member's receipt of notification of the Panel of Standards Committee's finding.
